RAMPART RANGE METROPOLITAN DISTRICTS NO. 4, 5, 6 & 8 JOINT DISCLOSURE TO PURCHASERS

This Joint Disclosure to Purchasers ("Joint Disclosure to Purchasers"), dated May 1, 2024, has been prepared by Rampart Range Metropolitan District No. 4 ("District No. 4" or the "Regional District"), Rampart Range Metropolitan District No. 5 ("District No. 5" or the "Managing District"), Rampart Range Metropolitan District No. 6 ("District No. 6"), and Rampart Range Metropolitan District No. 8 ("District No. 8" and, together with District No. 6, the "Taxing Districts") (collectively, the "Districts" or "East Side Districts"), to provide prospective property owners with general information regarding the Districts and their operations. This Joint Disclosure to Purchasers supersedes and replaces that certain Joint Disclosure to Purchasers recorded on February 15, 2023 in the real property records of Douglas County, Colorado at Reception No. 2023006384. This Joint Disclosure to Purchasers is intended to provide an overview of pertinent information related to the Districts and does not purport to be comprehensive or definitive. The property being purchased may be located within the Service Area of one or more of the East Side Districts. You are encouraged to independently confirm the accuracy and completeness of all statements contained herein.

DISTRICTS' ORGANIZATION / SERVICE PLANS/ MILL LEVY PLEDGE AGREEMENT

The property within the Rampart Range development is located within the boundaries of one or all of the East Side Districts. The Districts are quasi-municipal corporations and political subdivisions of the State of Colorado organized in Douglas County, City of Lone Tree ("City"), Colorado. The Districts operate pursuant to their respective Service Plans as approved by the City Council and as may be amended from time to time (the "Service Plans") and by the powers authorized by Section 32-1-1004, of the Colorado Revised Statutes (the "C.R.S.").

Each of the Districts was formed for the provision of water, street, traffic and safety, television relay and translation, transportation including regional transportation improvements, park and recreation, sanitation, and mosquito control improvements, programs, and services as defined in their Service Plans.

The Districts' Service Plans include a description of the Districts' powers and authority. Copies of the Districts' Service Plans are available from the Division of Local Government in the State Department of Local Affairs.

The Regional District entered into a Mill Levy Pledge Agreement dated November 7, 2017 (the "Pledge Agreement") with the City whereby the City and the Regional District agreed the boundaries of the Regional District would be modified to include all of the property within the service area of the Districts ("East Side Property") and that the Regional District will impose a Contractual Debt Levy (as defined in the Pledge Agreement) against the East Side Property and pledge the Contractual Debt Levy Revenue (as defined in the Pledge Agreement) generated thereby to the City for the benefit of the East Side Property, all in accordance with the express terms of the Pledge Agreement. A copy of the Pledge Agreement may be obtained from the District Manager at the contact information below.

DISTRICT BOARD OF DIRECTORS

Each of the Districts is governed by a five-member Board of Directors. Members of the Districts' Boards must be qualified as eligible electors of each District. The Boards' regular meeting dates may be obtained from the District Manager at the contact information below.

DEBT AUTHORIZATION

Pursuant to its Service Plan, District No. 4 has no authority to incur or issue debt other than to execute and perform its obligations as set forth in the Pledge Agreement.

The amount of debt District Nos. 5, 6, and 8 shall each be permitted to issue, under their respective Service Plans, shall not exceed Five Hundred Million Dollars (\$500,000,000).

TAXES AND FEES IMPOSED ON PROPERTIES WITHIN THE DISTRICT

Ad Valorem Property Taxes

The Districts' primary source of revenue is from property taxes imposed on property within the Taxing Districts. Along with other taxing entities, the Taxing Districts certify a mill levy by December 15th of each year which determines the taxes paid by each property owner in the following year.

Debt Service Mill Levy

The maximum debt service mill levy that District Nos. 5, 6, and 8 are permitted to impose under their respective Service Plans ("**Debt Mill Levy Cap**") shall be determined as follows: (1) for the portion of any aggregate District's debt which exceeds fifty percent (50%) of the District's assessed valuation, the maximum debt mill levy for such portion of debt shall be fifty (50) mills less the number of mills necessary to pay unlimited mill levy debt. The Debt Mill Levy Cap may be adjusted due to changes in the statutory or constitutional method of assessing property tax or in the assessment ratio. The purpose of such adjustment is to assure, to the extent possible, that the actual tax revenues generated by the mill levy are neither decreased nor increased, as shown in the example below.

Regional Mill Levy

Pursuant to its Service Plan, District No. 4 will impose a Regional Mill Levy in the amount of one (1) mill ("Regional Mill Levy") for payment of the costs of planning, design, permitting, construction, acquisition and financing of the Regional Improvements (as defined in the Service Plan). Pursuant to the Pledge Agreement, the Taxing Districts will not be required to impose a Regional Improvements Mill Levy (as defined in the Service Plans) to provide regional improvements for so long as District No. 4 certifies the Contractual Debt Levy (as defined in the Mill Levy Pledge Agreement and below) and remits the same to the City in accordance with the terms of the Pledge Agreement.

Operations Mill Levy

In addition to imposing a debt service mill levy, the Districts are also authorized by their respective Service Plans to impose a separate mill levy to generate revenues for the provision of administrative, operations and maintenance services (the "Operations and Maintenance Mill Levy"). The amount of the Operations and Maintenance Mill Levy may be increased as necessary, separate and apart from the Debt Mill Levy Cap.

- (a) If in 2005 the Actual Value of the property was \$500,000, and the Residential Assessment Ratio established by the State Legislature for that year was 7.96%, the Assessed Value of the property was \$39,800 (i.e., $$500,000 \times 7.96\% = $39,800$). If the District certified a combined debt and operations mill levy of 50 mills, it would have generated approximately \$1,990 in revenue for the District.
- (b) If in 2021 the Actual Value of the property remained at \$500,000 and the Residential Assessment Ratio decreased to 7.15%, the Assessed Value would be \$35,750 (i.e., $500,000 \times 7.15\% = $35,700$). Therefore, the District would certify a 55.664 mill levy in order to generate the same revenue as in 2005.

² Each mill is equal to 1/1000th of a dollar

³ The Colorado General Assembly passed Senate Bill 22-238 in 2022 which created multiple classes of property. For the sake of simplicity, this example only contains assessment ratios for single family and multi-family categories. In 2023, the Colorado General Assembly passed 23B-001, which set the Assessment Ratio for single family and multi-family property at 6.70% after the deduction from the Actual Value of the property of the lesser of either (1) \$55,000 or (2) the amount that causes the Assessed Value to be \$1,000 for property tax assessment year 2023.

(c) If in 2024 the Actual Value of the property remained \$500,000 and both the single family and the multi-family Residential Assessment Ratio was decreased to 6.70%, the Assessed Value for both a single family and a multi-family residential unit would be \$29,815 (i.e. $[\$500,000 - \$55,000] \times 6.95\% = \$29,815$). Because the single family Residential Assessment Ratio and the multi-family Residential Assessment Ratio were set at the same rate in 2023, if the District was comprised of solely residential units (single family or multi-family), it would need to certify a 66.745 mill levy in order to generate the same revenue as in 2005.

(d) Fees

The Districts have the power to assess fees, rates, tolls, penalties, or charges as provided in Title 32 of the Colorado Revised Statutes, as amended. District Nos. 5 and 6 and District Nos. 5 and 8 have adopted joint resolutions (as amended, "**Development Fee Resolutions**") imposing one-time development fees ("**Development Fee**") to assist in defraying the costs associated with the financing and construction of Public Improvements (as defined in the Service Plans) to be provided within the boundaries and/or service area of the Taxing Districts. The Development Fees are set forth below and shall be due and payable to District No. 5 ten (10) days after issuance of a building permit by the City.

District Nos. 5 and 6 and District Nos. 5 and 8 have also adopted joint resolutions (as amended, "Water Resource Credit Fee Resolutions") imposing one-time fees ("Water Resource Credit Fees") to defray and repaying the costs associated with the in the cost associated with development, including particularly, the connection to water utility systems. The Water Resource Credit Fees are collected in lieu of and in an amount equal to the Water Resource Toll fixed by the Parker Water and Sanitation District.

Copies of the Development Fee Resolutions and Water Resource Credit Fee Resolutions may be obtained from the District Manager at the contact information below and are posted on the Districts' website.

In addition to property taxes, the District may also rely upon various other revenue sources authorized by law to offset the expenses of capital construction and district management, operations and maintenance. For a current fee schedules, please contact the District Manager at the contact information below.

EXHIBIT AMap of the East Side Property


